Parent/Guardian Membership – <snip>

Each parent of a registered player shall be entitled to one (1) vote per player registered with a maximum total of two (2) votes per family. There is no cost for each parent/guardian membership and the deadline to register is 15 days prior to the AGM.

RATIONALE:

Many parents have questioned why the deadline is so early, and why it should cost anything if they are required to pay a full player registration fee to be eligible. This change would encourage more participation at the AGM.
