PRESIDENT'S REPORT

- Challenging year, but many positives
- We restarted the Steel City Tournament since prior to COVID
- It was a success and have established a foundation to continue running and improving the tournament
- U18AAA OHF was very successful
- We are looking forward to hold the U13AAA OHF in April put in a
- U12-U15AAA entered into Alliance program for a crossover 11 games and some showcases
- Team NOHA in addition to the OHL Cup two showcases for these teams one with OMHA and one
 with the Alliance
- U16AAA team is ready in the Great North U18 league
- U13, U15, U18AA went to the OHFs this year
- Thank all of the coaches, parents, and board members for all of the time and energy put into running this organization and the cooperation of everyone to make it successful

FINANCIAL REPORT - AUDIT FOR SAULT MAJOR

- Report is from May 31, 2022 to May 31, 2023
- Auditor's Opinion the financial statements and position are in a clean opinion
- May 31, 2022 and May 31, 2023 these were the numbers in the records on these two dates
- Decrease is due to cash in the bank, general operations, has decreased
- Accounts Receivable were quite high at the end of 2023 increase to outstanding registrations and about \$22,000 outstanding bills at the end of the season
- Liability money owed by Sault Major consistent between the two years
- 50/50 prizes not claimed must stay in the account for one year before donating it to a non-for-profit organization
- Money in the bank: \$259,000 compared to \$344,204
- Total Revenue \$663, 512 years (increase from last years)
- Registration has increased and an Elite team was added and a U18 team
- Expenses are \$754,017 compared to \$625,294 \$28,298 in bad debts
- Elite Team Refunds \$158,954 has increased (extra teams) from \$124, 580
- \$38,781 for jerseys, pucks, etc and increased
- Hockey Operations 2023 was \$35, 046 for 50/50 profit, compared to \$26,599 ion 2022

QUESTIONS

- Do we have to take the 20 tickets even if we don't use them? Ken Deplonty
 - Yes, there is a set amount in the Greyhound contract
 - No option to not pay for those tickets
- The increase from \$15 to \$62 why such an increase? Kristina Clayton
 - Angel was acting as Treasurer and saw the bills were not reflecting what the actual costs were
 - The teams had not been charged sufficiently to cover the costs
 - Angel raised the amount to cover the costs that were not being covered by \$15/player
- In the last two years, we have depleted resources. Where are we moving forward? What is the financial health moving forward? Carol Kennedy
 - We have approximately \$60,000 in the bank
 - Angel is not an accountant, but she believes we are in a stable financial state but we do need to look at registration costs to ensure we have enough to cover the rising costs.

- o June bank statements will be in about a week, but we will shortly
- We need to agree that we need to move forward with a Treasurer in place and ensuring that we are transparent and have clear breakdowns - Lori Zuccato
- When we see we lost a fair amount of money, can we have a better breakdown of the costs so that teams are blindsided by additional costs? Kristina Clayton
 - We can have a better breakdown for the Elite compared to A and HL
 - o General Overhead Costs breakdown for Non-Elite and Elite players
 - Recommended by Jennifer to do this
 - o Ice time, officials, time keepers we have the breakdown
- What equipment is covered? Kyle Jones
 - o We have always covered the shells for teams
 - This is the first year we have not covered the shells
- Can the costs be broken down more clearly to show costs? Lindsay Fera
 - We can make it more transparent and be more clear
- Where does the \$25/player for jerseys go from each Elite team? Carol Kennedy
 - All teams pays \$750 for registration
 - o The breakdown is to try and show teams what the expenses cover
 - HL and A stays within the registration
 - o Costs for jerseys cleaning tryout jerseys, alterations, repairs, etc
- What does a refund mean? Why is there a refund to teams? Anthony Wamsteeker
 - The Elite teams get ice bills monthly, for tryouts, etc
- What is the difference between HL, A, and Elite ice costs? Kristina Clayton
 - o lce time revenue comes from all teams
 - The entire ice bill is lumped together no matter the team
- Is it a combination of HL and/or Elite teams? Carol Kennedy
 - There is a record of it Dina sent the file
 - \$20,000 not paid registration
 - Write off? (not collected in 90 days)

FINANCIAL REPORT - 50/50

- Roxanne will summarize the 50/50
 - o Under our license we grossed \$179, 429.55
 - \$78,890 paid out to 50/50 winners
 - \$10,822 was not claimed in prizes and is on hold in the account
 - o Paid out \$11,265.08 to ASCEND for the machines and fees
 - \$589.75 to PAY SAFE
 - \$369 to First Data
 - \$7016.60 to Source for Sports for jerseys
 - o \$65,000 covers City ice bills
 - o \$31,005 covers Rankin ice bills
 - Overspent \$14,705.88

- There are no financials, can I suggest that the financial numbers are ready for the AGM? Rob Clayton
 - Agreed

- Why wasn't the Treasurer an immediate need for the executive? Adam Dunseath
 - We posted it and no one came forward
 - We need to fill this position and hopefully
 - The financials will be more clear moving forward
- There is an email from Tim explaining a difference in charges Craig Hartsburg
- If you take \$62/player, you collected approximately \$30,000 and put in the General Account, is this
 correct?
 - Portion of the 50/50 for the Greyhounds was about \$29,000
 - Ten Greyhound games approximately \$10,758.10 to the Greyhounds
 - Additional two games at \$2160 and Playoff Games at \$1275.77, \$1580.87
 - o Both Elite and Non-Elite teams have paid the cost
- Did you charge every player in SM hockey for \$62? Carol Kennedy
 - HL and A's registration covers the 50/50 costs
 - o Elite Teams -
- The jerseys are a cost of concern, do we have any proof of where their jerseys are being repaired, new sets being purchased, etc? - Matthew Inch
 - We try to just make sets with what we have
 - We have invoices and receipts for jerseys
 - o Ann has ordered just blank jerseys without numbers but in different sizes
 - We need goaltender jerseys because they do not fit players properly
- \$30,000 for jerseys, was that just Elite jerseys? Kyle Jones
 - We have a variable from year to year based on need
 - U18 players are harder on jerseys than U10
 - We try to minimize the cost, by replacing single jerseys or taking from another set
- Where is the draft for 2023/2024 financials? Adam Dunseath
 - At the end of June everything will be given to Jenn and we will have it done by
- What teams had banquets? Adam Dunseath
 - We had banquets this year
 - o In the past we gave money to the teams for individual parties
- Money charged per player has increased from \$15 to \$62, but we are not actually supposed to be charged according to AGCO.
 - We are told by AGCO where the money can go we can spend money for PAY SAFE and ASCEND
 - o The General Account covers all of the other expenses
 - o Added up costs, divided by number of players in the association
- Do the HL teams pay an ice bill? It is not shared equally and it should be. Lindsay Fera
 - No, registration covers their ice
 - There is a plan to elevate the concerns
- Do the teams get the money from 50/50 equally? Carol Kennedy
 - o Ice time, draft jerseys, Elite team jerseys
 - o It cannot benefit a single team
 - AGCO has never said to break it down team by team
 - o Rep teams may be on the ice for practices, but A and HL teams have all games at home
