

INTERIM ICE USER GROUPS ACCESS RULES

RANKIN ARENA (STAGE 3)

SCOPE: TO PROVIDE A SAFE, FUN, HEALTHY ENVIRONMENT FOR ALL USER GROUPS OF RANKIN ARENA

EVERY GROUP WILL BE REQUIRED TO COMPLETE A SITE VISIT WITH THE FACILITY MANAGER OR DESIGNATE AND SIGN A CONTRACT, PROVIDE PROOF OF LIABILITY INSURANCE (IF APPLICABLE), & SIGN A ICE RENTAL CONTRACT BEFORE BEING ELIGIBLE TO BECOME A USER GROUP AT RANKIN ARENA.

YOU WILL BE REQUIRED TO SUBMIT A PERSONELLE LIST/ROSTER PRIOR TO ACCESSING THE FACILITY AND FILL OUT A VISITOR LOG FOR EVERY BOOKING. THIS WILL ALLOW US TO TRACK AND HAVE DIRECT CONTACT WITH YOUR GROUP.

DO NOT ALLOW ACCESS TO ANYONE WITHIN YOUR GROUP THAT IS EXPERIENCING COVID-19 SYMPTOMS, COUGH, FEVER, FLU LIKE SYMPTOMS, OR HAS BEEN IN DIRECT CONTACT WITH SOMEONE WITH COVID-19.

AMATEUR & RECREATIONAL SPORTS LEAGUES MAY RESUME SO LONG AS THEY DO NOT ALLOW PROLONGED OR DELIBERATE PHYSICAL CONTACT BETWEEN PLAYERS OR IF THEY HAVE MODIFICATIONS TO AVOID PHYSICAL CONTACT BETWEEN PLAYERS.

SPECTATORS AT ALL SPORTING EVENTS WILL BE SUBJECT TO GATHERING LIMITS OF 50 PEOPLE PER ARENA INCLUDING PARTICIPANTS. PHYSICAL DISTANCING MEASURES WITH ASSIGNED & DESIGNATED SEATING WILL BE IMPLEMENTED. (NO SPECTATORS ALLOWED AT THIS STAGE)

YOU WILL BE DESIGNATED A SPECIFIC ENTRANCE TO COINCIDE WITH YOUR TIME SLOT. IE: HOME BENCH 5PM START TIME. VISITORS BENCH 6PM START TIME. THIS WILL ELIMINATE CONTACT BETWEEN GROUPS. ALONG WITH THAT YOU WILL HAVE A DESIGNATED REST ROOM AREA FOR YOUR GROUP TO COINCIDE WITH THE BENCH YOUR ARE ASSIGNED.

EACH CHILD WILL BE PERMITTED TO HAVE ONE PARENT/GUARDIAN WITH THEM. THEY WILL BE DESIGNATED A VIEWING SECTION TO COINCIDE WITH THE BENCH NAME.

NO EARLY ARRIVALS, YOU MAY ENTER THE FACILITY 15MINS BEFORE YOUR TIME SLOT IN ORDER TO PREPARE FOR YOUR ICE TIME.

NO OUTSIDE FOOD/BEVERAGE TO BE BROUGHT WITH YOU, INDIVIDUAL WATER BOTTLES ARE ALLOWED BUT MUST LABELLED, AND FILLED PRIOR TO ACCESSING THE FACILITY.

NO WARM UPS PERMITTED WITHIN THE ARENA, IF YOU SHOULD REQUIRE TO DO SO IT MUST BE DONE PRIOR TO ACCESSING THE FACILITY.

THERE WILL BE NO MORE THAN 10 PEOPLE IN A DRESSING ROOM AT A TIME

FOLLOW ALL OHF, HOCKEY CANADA RULES, POLICIES, GUIDELINES AT ALL TIMES.

1 HOUR RENTAL WILL CONSIST OF 50 MINS OF ICE TIME. THIS WILL ALLOW FOR THE FACILITY TO PERFORM ICE MAINTENANCE, HIGH TOUCH POINT CLEANING, AND MAINTAIN ALLOWED MAXIMUM GATHERING LEVELS AS SET BY HEALTH AUTHORITIES.

YOU WILL HAVE 15 MINS TO VACATE THE ARENA FOLLOWING YOUR ICE TIME.

ARENA EMPLOYEES & MEMBERS OF PUBLIC WHO ENTERS OR REMAIN IN A CITY FACILITY MUST WEAR A MASK OR FACE COVERING. EXCEPTIONS INCLUDE CHILDREN UNDER THE AGE OF TWO, THOSE WITH RESPIRATORY OR MEDICAL CONDITIONS THAT MAKE IT DIFFICULT TO WEAR A MASK OR THOSE WHO HAVE DIFFICULTY PUTTING A MASK ON THEMSELVES. ATHLETES PARTICIPATING IN ON-ICE ACTIVITIES ARE NOT REQUIRED TO WEAR A MASK. REFER TO ON-SITE SIGNAGE & INSTRUCTIONS.

THERE WILL BE NO LOST & FOUND. WE WILL NOT BE RESPONSIBLE FOR LOST ITEMS, BELONGINGS LEFT BEHIND (WITHIN REASON) WILL BE DISPOSED OF. SHOULD WE FIND AN ITEM OF SIGNIFICANT VALUE WE WILL RETAIN THE ITEM FOR 48 HOURS AND CONTACT THE GROUP DIRECTLY.

YOU MUST ALSO FOLLOW OUR GENERAL SET OF RULES AS PROVIDED

INDIVIDUALS WITH POSSIBLE CLOSE CONTACT EXPOSURE OF COVID-19 AT THE FACILITY WILL BE NOTIFIED
