The date shall be set by resolution of the Board on or before March 31st in each year unless otherwise determined by the Board.

The meetings of the Board shall be held at a place determined by the President or Secretary. Non-Board Members may request from the President the right to attend a regular Board meeting for making submissions upon not less than five (5) days prior written notice.

## Change to Read:

Regular Board Meetings shall be held monthly at the call of the President. Notice shall be given by the Secretary to each Director at least five (5) days prior to the date of the meeting. Such notice shall include a tentative agenda and have sufficient detail to enable the Directors to form reasoned opinions of the contemplated topics of discussions. The meetings of the Board shall be held at a place determined by the President or Secretary. Non-Board Members may request from the Board the right to attend a regular Board meeting for making submissions upon not less than five (5) days prior written notice. Such request will be directed to the Secretary to present to the Board.
